### **Special Resolution**

## The Resolution is to amend the Bylaws of the Society as follows:

Change name to **The Club Inclusion** in heading and Definitions.

#### par. 4 change to

4. Every member of the Society shall be entitled to attend any meeting of the Society and to vote at any meeting of the Society, but there shall be no proxy voting. Any member of legal age is eligible to hold any office.

#### par. 6 change to

6. The following shall be admitted to membership in the Society: any individual residing in Nova Scotia who supports the objects of the society.

## par. 10(a) change to

10 (a) The ordinary or annual general meeting of the Society shall be held within six months after the end of the fiscal year of the Society.

#### par. 22 change to

22. Unless otherwise determined by general meeting, the number of directors shall not be less than five and not greater than twelve. The first subscribers to the Memorandum of Association of the Society shall be the first directors of the Society.

### par. 24 change to

24. Directors shall retire from office at the end of each annual general meeting at which their successors are elected. Retiring directors shall be eligible for re-election twice, for a total of three consecutive terms. Past Directors may re-offer after an absence from the Board of two years. Directors shall be elected to two year terms, with one-half of the directors elected each year.
